Long Branch Community Meeting Notes



On April 23, 2009, we held our last Long Branch community meeting. Approximately 35 members of the Long Branch community attended the meeting. Melinda Malico took notes at the meeting. The following items were discussed:

- Because of a number of burglaries that occurred in recent months, we invited a representative of the Fairfax County Police Department to speak to us. Lt. David Crank was the featured speaker.
 - * Lt. Crank said that we live in one of the safest neighborhoods in the West Springfield District.
 - * Some of the burglaries were the result of a mentally challenged 18-year-old male who was breaking into houses seeking cough syrup.
 - * His primary messages are:
 - Lock your doors
 - Lock your windows
 - Lock your car
 - Noise is a deterrent
 - Cut back foliage from your house
 - Visible security system signs are helpful. However, due to the high number of false alarms, actually having a security system may not be that much of a deterrent
 - Dogs don't hurt
 - Bolt down your safe
 - The prime time for breaking into a home is from 8:30-2, when children are in school therefore the 8:30-2 time period is a good time to step up neighborhood watch!
 - * The most common items that are stolen from a home include:
 - Laptops
 - Prescription drugs
 - Computer games
 - * Lt. Crank discussed another pervasive problem today—identity theft. To avoid problems with identity theft, he recommended that you do not send your mail from your home mailbox.
 - * Lt. Crank mentioned that you can get a free home security survey by contacting the police department. (see http://www.fairfaxcounty.gov/oem/citizencorps/nw.htm for more information)
 - * Larceny is on the upswing, particularly of GPS systems in cars. Lt. Crank said that groups of teenagers steal the GPS systems and sell them, and that there have been 500 such thefts in the last eight months.
 - * He also mentioned that they see a lot of crimes (42 recently) of destruction, such as the shooting of pellet guns, particularly toward cars.
 - * Lt. Crank recommends that you lock the doors on your car and do not leave your garage door open. He mentioned a specific scam, in which residents are working out back in their yards, and leave the front door open. The perpetrators count the cars, and figure out how many people are home. If only one person is home, one of the perpetrators will occupy the person in the back yard while the other perpetrator breaks into the house!
 - * You should not leave a ladder outside, doing so invites burglars to climb into your house.
 - * Also, Lt. Crank mentioned that those who come around offering tree cutting services often prey on the elderly. They often ask for a deposit and never come back.

- * Lt. Crank circulated flyers an upcoming seminar on the growing problem of "sexting" among teenagers. He noted that teenagers may be unwittingly committing this crime, and cautioned parents to understand what the issues are.
- Additional notes from the meeting—
 - * Megan Davenhall kindly offered to be the coordinator for the Easter Egg Hunt.
 - * We still need a volunteer or group of volunteers to take over the Halloween Event.
 - * It was suggested that we launch a new "recommended contractor list" on our Web site.
 - * Someone suggested that we put up a "No Solicitation" sign at the community entrances. President Mark Wiggins said he would do so.
 - * The curb numbers were discussed.



Watch Neighborhood Watch News

Thanks to those families who have kept the Watch moving forward during the summer months: Burke, Heneghan, Edmonds-Everett, Cosby, Owens, Johnson, Gearing, Sik-Chong, Blanford, MacDonald, Wu-Zhang, Calhoun, Douglass, and Orleans-Pobee. Your efforts help to keep visibility high, a good crime prevention measure!!

As a result of our community meeting, several families have stepped up to form a new Daytime Watch program. We learned that burglaries tend to occur during school hours so some families have indicated interest in patrolling the neighborhood specifically during those hours. We hope to be completely organized within a month or so. Stay tuned.

Have you noticed the Neighborhood Watch signs in the community? There are two in place now, one at King David and Braddock, the other at Guinea and King David. We are working with the police to put up newer signs. Keep an eye out for them!

We have also ordered some new neighborhood watch car magnets. The oldies will be retired in the near term!

Final note -- Remember to ask Door-to-Door solicitors to see a Fairfax county permit before you consider buying products from them (with the exceptions of certain schools and religious groups). If you suspect something unusual about a person who has come to your door, feel free

to report this to the non-emergency police number (703-691-2131). You could ask for an officer to be sent to the neighborhood to speak with the solicitor. If you do this, try to recall as much detail about the person's physical description as possible -- you will be asked by the dispatcher. And, if you would like to know the outcome of the police officer's conversation with the person, you can ask the dispatcher to have the officer contact you afterward. Your Neighborhood Watch Coordinator took all these steps recently. Within 15 minutes of a suspected door-to-door scammer's visit, a cruiser was in the neighborhood. Regrettably, however, the police officer was not able to make contact with the suspicious person.

NEW FINANCIAL EDUCATION BUILDING

STUDENT SAFETY IS AN URGENT ISSUE


